Upon the successful completion of the course, you will be offered a training contract to complete your professional accounting qualification while gaining work experience with us.

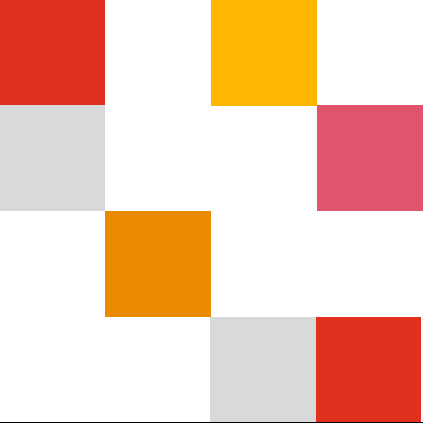

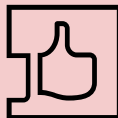

Junior Xplorer Programme

Get a headstart on your career



What is the Junior Xplorer programme?

The programme offers the opportunity to experience work placement in the Assurance line of service in PwC Malaysia through a 5-month employment contract from January to May.

You will be taking on the role and responsibilities of an Assurance Associate, and you will go through an onboarding programme and technical training.

You will have a headstart to join PwC Malaysia upon the successful completion of the programme and your professional exams (for students who are pursuing professional papers).



What are the requirements / eligibility criteria for this programme?

This programme is open to graduates and students who are pursuing professional papers:

- Graduates: A degree with a minimum of second-class upper or equivalent
- Students pursuing professional papers: in the final stage of their professional papers

If I'm currently pursuing my professional papers, will I be required to finish it during my work experience?

You will be working full-time, and will not be taking professional papers during the 5-month work experience.

Will the 5-month work experience be recognised in my length of service in the firm?

Yes, it will.

Will I be offered a job at the end of my contract period?

This will be subject to a few considerations such as availability of positions and your performance during your work experience. If you are offered to join us upon a successful completion of your Junior Xplorer contract, you will not have to go through a probationary period.

No.
